

”Biggest casting” Regulation – 2022

1. The Organizer of the contest “Biggest Casting” – 2022 (“Casting”) is

GLOBAL RECORDS SRL, a Romanian limited liability company, established according to the laws of Romania, with its registered office in Schitu, Constanta, address: str. Catedrala Tineretului nr. 3, room 1, registered at the Trade Register under no. J13/2630/2013, having unique registration code (CUI) RO26382443, hereinafter entitled “Organizer” in this Regulation.

The Casting refers to the scouting of artists organized in order to discover the best artists in the music field, who will benefit from a musical production contract and / or a publishing contract with the Organizer.

2. Eligibility: The Casting is open only to individuals who are over 18 years old on the date of registration or are expected to turn 18 until August 1st, 2022.

By registering for the Casting, the Participant declares full agreement with relevant obligations under this Regulation and undertakes to fulfil said obligations.

3. Contest calendar.

Preselection: Between 04.07.2022 and 04.08.2022, Participants can register for the Casting by filling out the registration form that can be found on the online platform of Global Records casting.globalrecords.com.

Also, by registering for the contest, the Participants agree to the use of the Participants’ identification elements (such as appearance, voice, name, etc.), which can be reproduced and used freely by the Organizer, unlimited in time and space, in all media outlets, either in part, or in full, in promotion and advertising materials of the Casting, without the need for any further approval from the Participant in this regard.

The preselection will take place online.

The selection of semi-finalists will be carried out on the basis of the votes given by each member of the jury.

The jury will consist of the A&R and artist services team of the Organizer, specialised in the music field. The criteria used by the jury will be as follows: correctness of interpretation, diction, stage appearance. The jury's decision is final, no appeals are allowed.

The contestants will be notified of the admission to the final selection stage by email and/or phone.

Final selection

The dates, times and locations of the final selection will be announced on the website casting.globalrecords.com, by email and by phone to the Participants. Upon entering the final selection, the Participants will be required to bring an ID with them.

At the final selection, the Participants will perform a live musical piece agreed upon with the Organizer.

Following the final selection, the winners will be chosen, and they will be put forward for negotiation to sign a musical production contract and/or a publishing contract.

4. Protection of personal data. By participating in the Casting, the Participant will reveal to us a series of personal information, such as name and surname, phone number, email address.

This information and personal data will be used for the purpose of contacting the Participants for the purpose of the Casting. By participating in the Casting, the Participant expresses unequivocal agreement that the Organizer collects relevant private data, stores it and processes it for the purpose of executing contractual obligations resulting from this Regulation.

According to Regulation (EU) 2016/679 (“General Data Protection Regulation” or “GDPR”) and any other applicable law, the Organizer has the obligation to process received personal data in a safe manner and only for the specified purposes. The personal data of the Participant will be stored by the Organizer as long as the Participant remains registered in the Contest. The Participant may, at any time whatsoever, request the Organizer to delete relevant data. The Organizer stores and processes the data of the Participant on the territory of Romania. The Organizer shall apply appropriate technical and organizational measures for the security of the Participant’s personal data, protecting said data against accidental or unlawful destruction, loss, alteration, disclosure or unauthorized access, as well as against any other form of unlawful processing. According to GDPR, the Participant has the following rights: the right of access, the right to correct mistakes in the Organizer’s files, the right to object to the processing of personal data, the right to request the deletion of personal data, the right to restrict data processing activities, the right to data portability, the right to lodge a complaint to the supervisory authority or to seek legal remedies. For the exercise of these rights, the Participant will send the Organizer a written request, dated and signed, at the business office in Bucharest, sector 1, Romania, address: str. 5. Publication of the Regulation

The regulation of the contest will be made public, free of charge, by publication on the website casting.globalrecords.com starting with 04.07.2022.

The Organizer reserves the right, upon sole discretion, to terminate, modify or suspend the competition, as well as the right to unilaterally change the calendar of the contest, thus promising to announce any changes in this regard.

This Regulation shall be binding on all Participants.

The Organizer reserves the right to amend this Regulation, any change being valid from the date of its publication on the Organizer’s website.

6. Litigation. Any disputes arising between the Organizer and the Participants in the Contest will be settled amicably or, if this will not be possible, the disputes will be settled by the courts of Bucharest.

7. Other clauses. The decisions of the Organizer are final and binding for all Participants.
